**家事調解服務收費表**

**登記費：**每方港幣\$100 (一次性，首次面談時支付)

**調解服務費：**

- 收費將按照申請人每月收入及資產值合併考慮。
- 資產值超過港幣\$3,000,000 (可豁免一個自住物業)者，調解服務費為每小時港幣\$1,000。

- 面談時間若不足 1 小時，則每 15 分鐘一計，不足 15 分鐘亦作 15 分鐘計。
- 單獨面談及共同面談的收費均以個人單位計算，每方須負責繳付自己單獨及共同面談的費用。
- 各方須於面談結束時繳付當天之所有費用。

**草擬協議書費用：**

- 首份草擬，每方須繳付 2 小時之服務費。
- 之後每份修訂草擬，每方須繳付半小時之服務費。
- 如收入為港幣\$15,000 或以下者，收費可獲豁免。

**備註：**

- 有經濟困難之人士可申請減免費用。就批核減免費用之申請，本會有最終決定權。
- 本會保留就以上收費隨時作出調整的權利。

**法律援助個案：**

**登記費：**每方港幣\$100 (一次性)

**調解服務費：**每方每小時港幣\$1,000

- 面談時間若不足 1 小時，則每 15 分鐘一計，不足 15 分鐘亦作 15 分鐘計。
- 單獨面談及共同面談的收費均以個人單位計算。每方須負責繳付自己單獨及共同面談的費用。

**草擬協議書費用：**

- 首份草擬，每方須繳付 2 小時之服務費。
- 之後每份修訂草擬，每方須繳付半小時之服務費。

**行政費：**每方須繳付 2 小時之服務費 (包括聯絡工作、閱讀文件、文書工作等)。

**Fee Scale of Family Mediation Service**

**Registration Fee:** HK\$100 per party (one off, to be paid in the first session)

**Mediation Service Fee:**

- Both monthly income and asset value of the applicant will be considered for determination of mediation service fee.
- For parties whose asset value exceeds HK\$3,000,000 (may exclude one property for self-living), mediation service fee is HK\$1,000 per hour.

- For odd minutes, it is counted at quarterly basis, even time used is less than 15 minutes.
- Both individual and joint session fees are calculated on individual basis. Each party is required to pay for his/her own individual and joint session fees.
- All fees are to be paid at the end of each session.

**Fee for Drafting Settlement Agreement:**

- First draft: Each party is required to pay for 2 hours of service fee.
- Each subsequent revised draft: Each party is required to pay for half an hour of service fee.
- Fee will be waived for parties who have income of HK\$15,000 or below.

**Remarks:**

- Parties who have financial difficulties may apply for fee remission. The Council has the discretion in the approval of application for fee remission.
- The Council reserves the right to adjust the above fee scale at any time.

**Legally-Aided Cases:**

**Registration Fee:** HK\$100 per party (one off)

**Mediation Service Fee:** HK\$1,000 per hour per party

- For odd minutes, it is counted at quarterly basis, even time used is less than 15 minutes.
- Both individual and joint session fees are calculated on individual basis. Each party is required to pay for his/her own individual and joint session fees.

**Fee for Drafting Settlement Agreement:**

- First draft: Each party is required to pay for 2 hours of service fee.
- Each subsequent revised draft: Each party is required to pay for half an hour of service fee.

**Administration Fee:** 2 hours of service fee (e.g. contacts, reading documents, paperwork, etc.) will be charged for each party.
