Mr. Vod K. S. Chan

Mr. Vod K. S. Chan is a practicing barrister and arbitrator, as well as an accredited general and family mediator of the HKIAC and the HKMAAL. As mediator, he often assists clients in resolving different types of disputes, especially those of matrimonial nature. And, he often promotes mediation in various institutions, including non-profit and academic organisations as well as major private sectors. In addition, he is also invited from time to time to act as coach or trainer in various mediation or negotiation courses, and has written many articles on mediation or negotiation for publication in newspapers and journals. In 2018, he coached a team of CityU law students which was crowned the Champion at the ICC Mediation Competition in HK, and he then led the team in 2019 to compete in the ICC Mediation Competition in Paris with its first appearance recognised. In addition to his previous judicial appointments, since 2021 he has from time to time sat on the bench as Deputy Registrar to facilitate settlement among disputing parties in court room.



Ms. Katrina Wu

Ms. Katrina Wu was admitted as a Registered Social Worker in 2002. She was accredited as a Family Mediator in 2006, and she started her practice as a Family Mediation Supervisor since 2010. She is an active Family Mediator and Family Mediation Supervisor. She is now the Centre Supervisor of the Marriage Mediation Counselling Service Centre of the Hong Kong Catholic Marriage Advisory Council. Practicing as a Social Worker, Family Mediator and Family Mediation Supervisor, Katrina has integrated negotiation and counselling skills with her understanding on human nature in handling couples and families. She delivered workshops and talks on family mediation and divorce issues to SWD, NGO's, universities, churches, people facing divorce and the general public with a mission to promote a harmonious and caring society. She is one of the authors of the following books published by the Hong Kong Catholic Marriage Advisory Council: 《怎可和諧共處 — 面對家庭衝突的生活智慧》, 《家事調解實務與技巧》, and 《孩子解惑師 — 容納孩子心聲調解模式個案分享》.

Ms. Man Chung is a registered social worker and works for youngsters at the beginning of her social work career. Starting from 2013, she has become a family mediator and turned to full-time practice in 2015 in HKCMAC Marriage Mediation Counselling Service Centre. As a Family Therapist, she is especially interested in integrating micro-counselling skills in the mediation process to promote client's co-parenting abilities while practicing the Therapeutic Mediation Approach. Being trained to be a Child-inclusive Mediator, Man also put her efforts in helping families with teenage children by using CIM's child assessment techniques on reflecting children's needs and emotions which can facilitate parent's agreement accomplishment.

‘Guideline for attending webinar’ 「參加網上研討會指引」：

1. Choose an appropriate place:

Make sure you choose a quiet place, no matter at home or other places, that there will be no disturbances when you attend the webinar.

2. Prepare visual media with:

(i) A computer with camera and with reliable internet;

(iv) Please join the meeting 15 minutes earlier and wait at the waiting room for registration.

3. Respect and protection of privacy:

Participants are requested to read and agree with the “Guideline for attending webinar” before they receive the Zoom link and password. Participants should not share the Zoom link and password with others. During the webinar, no video/ audio recording nor pictures capturing are allowed.
